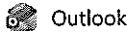

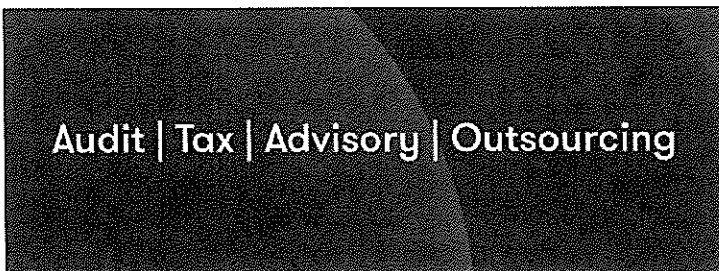
We have not yet received the IT audit report for Loqus. As communicated earlier, NAO doesn't have a copy of it.

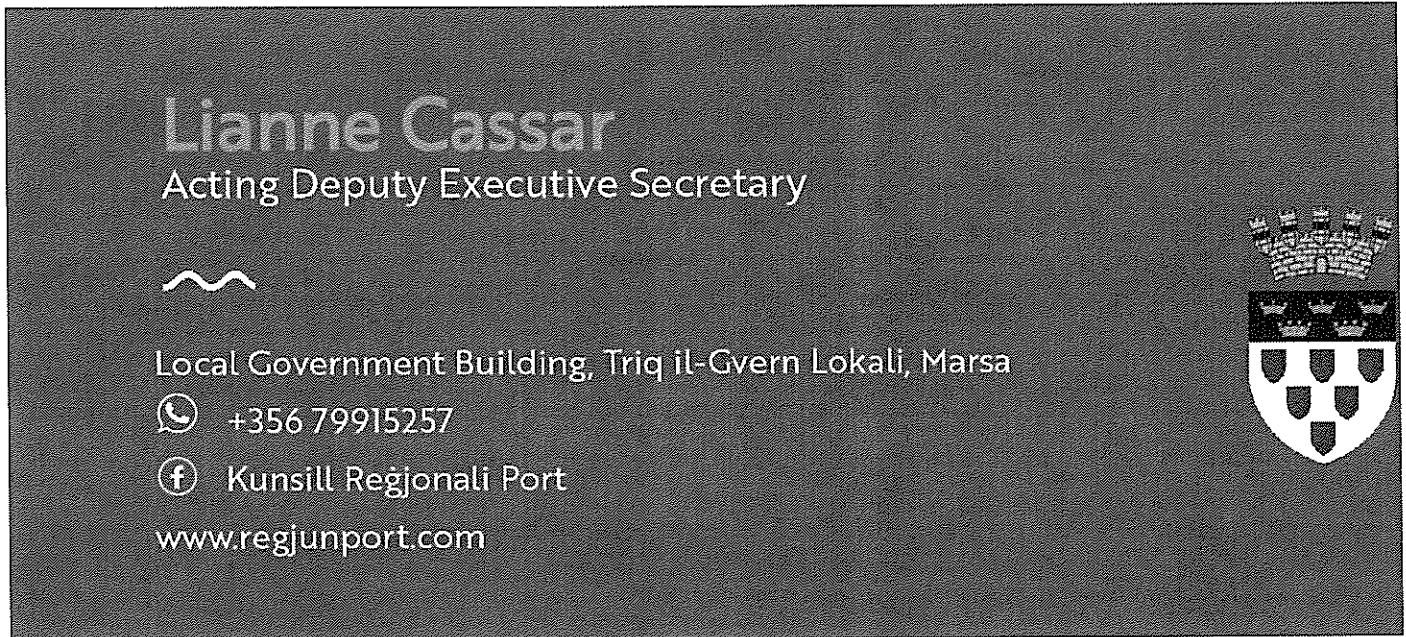
As we are approaching the closure of the audit process for the Port Regional Council, I would like to kindly ask whether there are any updates regarding the matter below.

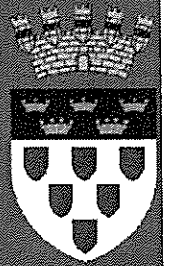

Dear Ms. Cassar,

Apologies for the delay in our reply.

Kindly note that yearly IT Audits are carried out on LES as part of our Company Financial Audits.

Moreover, an independent IT Audit was carried out on the LES System in 2021 and this is periodically refreshed.

This IT Audit has been commissioned by LESA (based on the parameters recommended by NAO) and the report and findings were shared with LESA and with NAO.

In relation to specific discrepancies, one would need to understand how data presented in LES is accounted for in the Region's Accounting System.

LES has a specific set of reports used for EOY that are static and are not affected by time differences (that was a concern in the past reports).

Such discrepancies can also be investigated on request.

Obviously, we have no control over the physical funds transferred between entities and we cannot take responsibility for reports showing that the money was transferred but the funds haven't yet actually been received in the bank account.

Kindly note that the management letter for Regjun Port highlights ongoing issues related to the Loqus system. As the financial statements of the Region are partially dependent on information obtained from Loqus reports, the Council is formally requesting an IT system audit.

Please refer to the letter linked below, particularly points 1.2 and 2, which outline the concerns. It appears that this matter has been noted repeatedly in the Regional Council's management letters by auditors, and thus warrants a closer review.

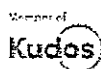
