Dan huwa meħtieġ sabiex l-estimi finanzjarji għas-sena 2026 ikunu jistgħu jerggħu jinħadmu u jiġu allinjati mal-linji l-ġodda tal-kontijiet.

Hija spjegat li, sal-ġurnata tal-laqqgħa, dan it-template kien għadu ma wasalx għand il-Kunsill. Għaldaqstant, il-kolonna tal-Budget fir-Rapport Finanzjaru ppreżentat tħalliet vojta, peress li l-Budget originali mhejji fil-bidu tas-sena ma kienx jikkorrispondi mal-linji u l-klassifikazzjonijiet il-ġodda ntrodotti fir-Rapport Finanzjaru taħt iċ-Chart of Accounts il-ġdida.

Id-Deputat Segretarju Eżekuttiv spjegat li, hekk kif jiġi pprovdut it-template meħtieġ mid-Divizjoni għall-Gvern Lokali, tkun tista' ssir ir-reviżjoni u l-allinjament tal-estimi għas-sena 2026 skont il-format il-ġdid.

Hija semmiet ukoll li kien importanti li jiġu ċċarati l-implikazzjonijiet li jista' jkun hemm fuq attivitajiet diġà pplanati mill-Kunsill Lokali u mir-Reġjun Port fl-istess binja.

L-ewwel prijorità kienet it-triq parallela ma' Triq il-Barrani, li sservi bħala service road u tinsab ftit aktar 'l isfel mill-pompa tal-petrol. It-tieni prijorità kienet ix-xogħolijiet meħtieġa fl-isqaqien fi Triq Santa Marija li għadhom ma tlestewx.

Dawn iż-żewġ interventi ġew identifikati bħala l-ewwel prijoritajiet li għandhom jiġu segwiti ma' Infrastructure Malta.

Agenda

To discuss the current use of the Council sports grounds by Tarxien Rainbows F.C., consider a proposed revision to the training schedule, and discuss other requests submitted by the Club.

Matters Discussed

1. Current Training Schedule

The Council informed that the MoU stipulates the current available schedule for Tarxien Rainbows:

2. Proposed Training Schedule

The Club explained that the proposed schedule would provide greater flexibility for its training programme and facilitate the organisation of youth training sessions.

The Deputy Executive Secretary and the Councillor responsible for Sports reminded those present that the primary purpose of the refurbishment of the Council football pitch was to provide **an accessible and free recreational space for children and young people from Tarxien**, allowing them to use the facility without necessarily having to enrol in structured training programmes or be bound by the fixed schedules of sports clubs. It was emphasised that preserving this flexibility remains a key objective of the Local Council and will be a determining factor when considering any requests for the allocation of the facility.

It was agreed that the Councillor responsible for Sports would present the Club's request and the discussions held during this meeting at the next meeting of the Local Council, where a final decision on the proposed training schedule will be taken.

3. Request for the Purchase of Laptops

Tarxien Rainbows F.C. requested whether the Council could purchase **two laptop computers** for use by the Club.

During the meeting, the Deputy Executive Secretary clarified that the Local Council is **not legally permitted to purchase assets or donate equipment to third parties**. Following this clarification, the representative of Tarxien Rainbows F.C. immediately withdrew the request, and no further action was required.

Meeting with Cat Feeders

Date: Monday, 13th July 2026

Time: 6:00 p.m.

Venue: 97, Triq Santa Marija, Tarxien

Present

Agenda

To discuss concerns raised by cat feeders regarding the welfare and protection of stray cats within the locality and to identify possible actions by the Council.

Matters Discussed

1. Dogs Roaming Freely and Attacking Cats

Cat feeders expressed serious concern regarding dogs that are allegedly being left to roam freely in public areas, particularly around **Triq il-Kavallerija**. They reported that these dogs are hunting and killing stray cats, with most incidents occurring at approximately **2:00 a.m.**

It was further reported that the dogs are believed to belong to a nearby cow farm and horse stables. The Council acknowledged the seriousness of the allegations and agreed that the matter requires immediate attention in the interest of both animal welfare and public safety.

2. Referral to the Community Police

The Council informed those present that the matter would be formally referred to the **Community Police**, requesting an investigation and any enforcement action deemed necessary. The Council stressed the importance of addressing the issue promptly before it escalates further.

The meeting discussed the need to verify whether the CCTV cameras located in **Triq il-Vigorelli** and **Triq il-Ħaġar** are operational and recording. Any available footage may assist the investigating authorities in identifying those responsible.

4. Cat Crossing Signs

The cat feeders requested the installation of "**Cat Crossing**" signs in the vicinity of:

- Ġnien Mark Farrugia.
- Ġnien Penza.

The Council agreed to assess the feasibility of installing the requested signage.

5. Educational Campaign

The participants discussed the need to increase public awareness on:

- Responsible pet ownership.
- The importance of keeping dogs under control at all times.
- Respect for animal welfare and managed cat colonies.

The Council agreed to explore the possibility of organising an educational campaign in collaboration with the relevant authorities and stakeholders.

6. Participation in Local Council Events and Collaboration with the Active Ageing Centre

The cat feeders expressed their interest in participating in Local Council events through the organisation of **bazaar and fundraising sales**. Such initiatives would help raise funds to support the care and welfare of the managed cat colonies while also promoting greater public awareness of their work within the community.

The meeting also discussed the possibility of establishing a collaboration with the **Active Ageing Centre in Tarxien**. The proposed collaboration would seek to encourage community participation, volunteering and intergenerational engagement through activities related to animal welfare and responsible pet ownership.

The Council welcomed the proposal and agreed to explore opportunities for involving the cat feeders in future Council events and to liaise with the Active Ageing Centre to identify suitable joint initiatives.
